## TOURNAMENT RULES

1. This tournament is conducted by the Morris County NJ USBC and all USBC Rules will apply. 2. ELIGIBILITY: Entry is open to any USBC certified Bowlers that have sanctioned through 2022. 3. ALL BOWLERS must present a current USBC Membership Card ('21-'22 or '22-'23 season(s)).
If they have not already done so, bowlers shall sanction in the Morris County NJ USBC. The fee to sanction in Morris County shall be $\$ 12$, which applies to both prepaid $\&$ walk-in entries.
2. LANE ASSIGNMENT: Lanes will be pre-assigned by the Tournament Director. A maximum of 4 Bowlers per Lane. A maximum of ONE (1) lane courtesy each side per bowler (USBC Rule 303).
3. ENTRY FEE shall be \$80. Payment may be by check (payable to: Morris County NJ USBC) in advance, postmarked by October 16th. Cash will be accepted at the door.
4. PRACTICE: Tournament Practice will be before 1 st game only of each round. 10 minutes for qualifier round, 5 minutes for first match play round, 2 balls per lane for each additional round.
5. TIES: 1 game roll off for the last finalist from the Qualifying Round. Seeding will be based on pinfall, then high game.

Replay 9th \& 10th frame of second game for each match play round.
8. FORMAT: (This is a Scratch Division Only Tournament) 5-game qualifier across lanes moving to a new pair each game. Lanes will be re-dressed between the qualifying and start of the final rounds. One (1) in 8 bowlers advance to seeded match play. Matches will be single-game, single-elimination (I.E. one-game matches until we have a champion), with total pinfall determining the winner.
The Kegel Abbey Road oil pattern will be used.
9. OPTIONAL: Brackets will be run games 2-4 of qualifying. (\$5.00/Bracket). Side Pots will also be offered.
10. TOURNAMENT PRIZE WINNINGS: USBC Rule 319d, concerning Tournament Prize Winnings of $\$ 300$ or more in cash or merchandise is waived for this Tournament.
11. FINAL PRIZE PAYOUT for positions will be awarded at a 1 in 5 bowler ratio.
12. TOURNAMENT DIRECTOR: reserves all rights (USBC Rule 303).
13. If a bowler wins $\$ 600$ or more in event(s) in a calendar year, they will be given a 1099 form.
