## Tournament Rules:

1. **THIS TOURNAMENT** is conducted by the Morris County NJ USBC Association and all USBC rules will apply.
2. **ELIGIBILITY:** Entry is open to adult bowlers of all Mens, Womens, and Mixed leagues, Winter and Summer, sanctioned through the MORRIS COUNTY NJ USBC.
3. **TEAMS** may consist of any doubles combination (male/male, male/female, or female/female).
4. **MULTIPLE PARTICIPATION** will be allowed, but each entry must be with a different partner. See USBC rule 315b2
5. **AVERAGES** – All bowlers will use their highest 2018-2019 winter league book average for 21 games or more. If no 2018-2019 winter average is established, a 2019 Summer average of 21 games or more will be used. If a contestant has no 2018-2019 summer or winter average, then bowlers will use their highest average of 21 games or more as of May 10<sup>th</sup> 2020. All others will use a 230 scratch (see USBC Rule 319b) average. Sport League averages will be adjusted per USBC Rule 201. Verification of average may be necessary. Composite averages will be waived throughout this tournament. See USBC Rule 319a-1b
6. **TEN PIN RULE** USBC rule 319a-2 (Ten pin rule) will be waived for this tournament.
7. **HANDICAP** – The handicap per game will be 100% of the difference between the teams entering average and 460.
8. **ENTRANTS RESPONSIBILITY** – It is the bowler's responsibility to verify the accuracy of his/her Morris County average reported for use in this tournament. Failure to use the proper average or to make corrections prior to the completion of the first game, shall disqualify the bowlers score from all prizes, if submitted average is lower than their correct average. Prize winnings will be based on the submitted average if it is higher than the correct average. (see USBC rule 319a3) No adjustments will be made after the **completion of the FIRST GAME**. (see USBC rule 319a4) unless approved by the Tournament Director.
9. **AVERAGE ADJUSTMENT** – All entrants should be familiar with the revised USBC rule 319c concerning average adjustment.
10. **LANE ASSIGNMENT** – Lanes will be pre-assigned by the Tournament Director. There will be a maximum of FOUR Doubles Teams per pair of lanes (8 bowlers per pair). There will be **ONE LANE COURTESY** to each side of a bowler during delivery. (USBC rule 303)
11. **ALL BOWLERS MUST PRESENT PROOF OF THEIR CURRENT MORRIS COUNTY USBC MEMBERSHIP**. Temporary card, permanent card, and electronic proof of membership shall be acceptable. Cost of a membership card on site shall be \$25.00
12. **PRACTICE** – Tournament bowlers will NOT be permitted to open bowl on the day of competition at the center prior to tournament participation.
13. **TOURNAMENT PRIZE WINNINGS** – USBC Rule 319d concerning Tournament Prize Winnings of \$600 or more in cash or merchandise will be waived for this tournament.
14. **PARENTAL CONSENT** – USBC Rule 13 concerning parental consent applies. Forms will be available at the Tournament site
15. **TOURNAMENT DIRECTOR reserves all rights (USBC Rule 303)**
