SUPERIOR PERFORMANCE

Eligibility: Superior Performance Candidates shall be chosen on the basis of bowling achievements, tournament titles, awards, integrity, sportsmanship, character, and contribution to the game of bowling in general over a period of at least fifteen years. The following are the minimum requirements for candidate consideration:

1. Adult membership (Winter) in good standing in the Morris County NJ USBC (or its predecessors) for a minimum of fifteen years.
2. Must have participated in 20 County Tournaments (combination of Annual Championship, Doubles/Mixed Doubles, Masters, Queens/Princess, Elite and Charity)
3. Only fully completed forms will be accepted!

The Morris County NJ USBC Hall of Fame Committee Members will elect members to the Morris County NJ USBC Hall of Fame by ballot. The committee shall return credentials to any unsuccessful candidate so they can update and resubmit for future consideration.
