## Tournament Rules – Read Carefully

1. ELIGIBILITY – All female bowlers must be certified with USBC and THE MORRIS COUNTY NJ USBCASSOCIATION prior to tournament participation for the Season 2020-2021.
2. ENTRY FEES – All fees must accompany entry. CHECK or MONEY ORDER ONLY is to be made payable to: THE MORRIS COUNTY NJ USBC. Mail entry and check to: Morris County NJ USBC, 117 Woodmont Drive, Randolph, NJ 07969 prior to MIDNIGHT April 19, 2021. **No Entry Fees Returned – See USBC Rule #314.** Entries will be scheduled in the order they are received. **[All returned check fees charged to Morris County NJ USBC will be the responsibility of the person whose name appears on the check.]**
3. **\* AVERAGES TO BE USED IN PREFERRED ORDER – HIGHEST USBC AVERAGE (Rule 319a-1b does not apply)**
  - a. Highest final Winter (regular or substitute) certified average of 21 games or more for the 2019-2020 season.
  - b. Bowlers who have no 2019-2020 Winter season certified average, use highest (regular or substitute) final 2019 Summer League Certified Average for 21 games or more.
  - c. If no 2019 Summer Average, use highest 2018 Summer League Certified Average for 21 games or more.
  - d. Bowlers who do not have either a, b or c are new bowlers this season and should leave the average section blank when submitting this application. Bowler must have an average verification from a league secretary or a standing sheet with the highest certified average (regular or substitute) for 21 games or more as of April 1, 2021 or rule 3E will apply.
  - e. Bowlers who do not have either a, b, c or d must use a 220 average.
4. Rules 319C, 319D and 319E do not apply. Rule 201C will apply (all sport averages will be re-rated.)
5. Net and Handicap brackets will be available.
6. ENTRANT WILL BE DISQUALIFIED, AND WILL LOSE RIGHTS TO PRIZE MONEY AND/OR TROPHIES IF SHE BOWLS UNDER AN INCORRECT AVERAGE! IT IS THE BOWLER'S RESPONSIBILITY TO VERIFY HER AVERAGE BEFORE TOURNAMENT PLAY.
7. A BOWLER MAY ENTER SINGLES AND DOUBLES MORE THAN ONCE PROVIDED PARTNER IS CHANGED. A BOWLER MAY ENTER TEAM EVENT MORE THAN ONCE PROVIDED TWO OR MORE BOWLERS ON THE TEAM ARE CHANGED.
8. All entries must be made on OFFICIAL ENTRY BLANKS, with proper line-up, accompanied by Check or Money Order for Entry Fees. TEAM FEES: \$128.00, DOUBLES:\$64.00, SINGLES: \$32.00. Paid ALL EVENTS (\$5) are not transferable unless the substitute replaces the original entrant in all three events and the transfer is made by the Tournament Manager or her assistants prior to the time of the substitute's participation in any event. Substitute(s) shall be allowed in each event (team, doubles, and singles). A substitute shall take the place in the lineup of the original entrant. A substitute will not be required to reimburse the original entrant with the entry fee paid nor shall the substitute be expected to give the original entrant any prize money or trophy she may win. The bowler's first appearance in team, doubles and singles events count toward the all events total. Entrants may cash only once in singles, based on highest singles series.
9. **Positively no delays or postponements allowed. Bowlers arriving late will start to bowl in the same frame the Team is bowling. No score for any frames not bowled.**
10. **DELAY OF GAME: Be ready to bowl when your name appears on the monitor. If not ready to bowl, you will receive zero (0) for each frame you missed. A ONE LANE COURTESY WILL BE STRICTLY ENFORCED.**
11. A sponsored team must have the Official Sponsor's name in full. Any team having names which are "nick-names" or partial Sponsor's name will not be recognized as a Sponsored Team and will not be eligible for Sponsor Trophy.
12. If an illegal entry should be accepted, through error, all fees paid on such entry shall be null and void. No entry money will be returned.
13. Blind scores or pacers will not be permitted.
14. Doubles and Singles events will be bowled on the same pair of lanes.
15. **HANDICAP:** 90% based on Teams 1000, Doubles 500 and Singles 250. Teams over 1000, Doubles over 500 and Singles over 250 will bowl SCRATCH (maximum 3-game handicap based on scratch).
16. **PROPER ATTIRE:** BOWLERS ARE REQUIRED TO WEAR SUITABLE ATTIRE WHEN PARTICIPATING IN THE MORRIS COUNTY NJ USBC ANNUAL WOMEN'S CHAMPIONSHIP TOURNAMENT.
17. Any protest affecting eligibility or general playing rules must be confirmed in writing to the Tournament Manager not later than 24 hours after the game has been bowled. The Tournament Committee shall have the power to hear and act on all protests. Every entrant is responsible for her score.
18. The entrants whose names appear hereon, or their authorized replacements, hereby agree that the Morris County NJ USBC, its Officers and Directors shall be liable only to the extent of returning entry fees for unexpected yet necessary schedule change, or premature termination of the tournament, which may be brought about by war, strikes, lockouts, labor difficulties or other causes beyond the control of the Morris County NJ USBC.
19. Ties for first place: In case of a tie for first place in any event, the team or individuals shall be declared Co-Champions. First and second place money shall be equally divided and all other ties shall be equally divided. Awards will be given to Co-Champions.
20. USBC Rule #327C regarding scores and #328 regarding Changing Delivery in Handicap and Classified Tournaments shall apply.
21. THE TOURNAMENT COMMITTEE SHALL HAVE THE RIGHT TO MAKE A CHANGE IN PROCEDURE WHEN NECESSARY!
22. ALL THESE RULES AND THE TOURNAMENT RULES OF USBC WILL BE STRICTLY ENFORCED BY THE COMMITTEE.
23. **IF A BOWLER WINS \$600.00 OR MORE IN TOURNAMENT(S) WITHIN A CALENDAR YEAR (JANUARY 1<sup>ST</sup> TO DECEMBER 31<sup>ST</sup>) THEY MUST BE ISSUED A 1099 MISC TAX FORM. IN ORDER FOR OUR ASSOCIATION TO COMPLY, THE BOWLER MUST SUBMIT THEIR SOCIAL SECURITY NUMBER WHEN REQUESTED.**
