

# Application for Veteran Superior Performance Male Category 

## VETERAN SUPERIOR PERFORMANCE - MALE CATEGORY

Eligibility: Veteran Superior Performance Candidates shall be chosen on the basis of bowling achievements, tournament titles, awards, integrity, sportsmanship, character, and contribution to the game of bowling in general. To qualify for consideration for induction for bowling achievement under the Veterans Category, the candidate must:

1. Be a minimum of 60 years of age.
2. Have a minimum of 30 years of sanctioned bowling in Morris County NJ USBC (or its predecessors) OR had a minimum of 15 years in an earlier era (pre-1990) for which his candidacy is being considered.
3. Have participated in 20 County Tournaments (combination of Annual Championship, Doubles/Mixed Doubles, Masters, Elite, Champion of Champions and Charity).
4. Only fully completed forms will be accepted!

Candidate must have minimum 300 points to be considered. The Morris County NJ USBC Hall of Fame Committee Members will elect members to the Morris County NJ USBC Hall of Fame by ballot. The committee shall return credentials to any unsuccessful candidate so they can update and resubmit for future consideration.
