TOURNAMENT RULES

1. **THIS TOURNAMENT** is conducted by the Morris County NJ USBC Association and all USBC Rules will apply.
 2. **ELIGIBILITY** -Entry is open to all bowlers of all **Men's, Women's & Mixed** Winter and Summer Leagues through the MORRIS County NJ USBC.
 3. **TEAMS** may consist of any combination.
 4. **MULTIPLE PARTICIPATION** will be allowed, but only with a different partner (USBC Rule 315b2)
 5. **AVERAGES** - All bowlers will use their highest **2022-2023 Winter League Average** for 21 games or more. If no 2022-2023 Winter League Average, bowlers will use their highest **2023 Summer League Average** for 21 games or more (USBC Rule 319a1a). If no average from last year (Winter or Summer), bowlers will use their highest average this year, for 21 games or more as of May 15, 2024. All others will use 230 Scratch (USBC Rule 319b). Sport League Averages will be adjusted per USBC Rule 201. Verification of average may be necessary. Composite Averages will be waived throughout this Tournament (USBC Rule 319a1b).
 6. **TEN PIN RULE** - USBC Rule 319a2 (Ten Pin Rule) is waived for this Tournament.
 7. **HANDICAP** – The handicap per game is 100% of the difference between the team's total entering average and 460.
 8. **ENTRANT'S RESPONSIBILITY** - It is the bowler's responsibility to verify the accuracy of his/her Morris County average reported for use in this Tournament. Failure to use the proper average or to make a correction prior to completion of the first game shall disqualify the bowler's scores from all prizes if submitted average is lower than their correct average. Prize winnings will be based on submitted average if it is higher than the correct average, (USBC Rule 319a3). NO adjustments will be made after the FIRST GAME (USBC Rule 319a4), unless approved by the Tournament Director.
 9. **AVERAGE ADJUSTMENT** - All entrants should be familiar with the **revised** USBC Rule 319c concerning Average Adjustment.
 10. **LANE ASSIGNMENT** - Lanes will be pre-assigned by the Tournament Director. A maximum of four Doubles Teams per pair of lanes (8 Bowlers per Pair). A maximum of **ONE (1) lane** courtesy each side per bowler while bowling (USBC Rule 303).
 11. **ALL BOWLERS MUST PRESENT CURRENT MORRIS COUNTY NJ USBC MEMBERSHIP CARD OR TEMPORARY MEMBERSHIP STUB OR PURCHASE A MEMBERSHIP CARD AT TOURNAMENT SITE (\$27.00), USBC RULE 300c1.**
 12. **PRACTICE** - Tournament Bowlers will not be permitted to open bowl at this center on the day of their participation.
 13. **TOURNAMENT PRIZE WINNINGS** - USBC Rule 319d, concerning Tournament Prize Winnings of \$600 or more in cash or merchandise is waived for this Tournament.
 14. **PARENTAL CONSENT** - USBC Rule 13 concerning Parental Consent applies. Forms will be available at the Tournament site.
 15. **TOURNAMENT DIRECTOR** reserves all rights (USBC Rule 303).
